1. The present petition is filed challenging the order dated 03.12.2024 passed by Respondent No.2, pursuant to which the petitioner was directed to make changes in its name within a period of three months.

2. The learned counsel for the petitioner submits that the petitioner was originally incorporated as 'Shivalik Prints Private Limited' and was later renamed as 'SPL Industries Limited' with the approval of the Registrar of Companies on 26.09.1994. He submits that the impugned order was passed erroneously noting that the Respondent No. 5/Company having identical name was incorporated prior in time. He submits that Respondent No. 5/Company was initially incorporated as 'Shanti Dyeing and Printing Mills (Bombay) Private Limited' and finally kept a similar name as petitioner on 01.11.1995, that is, pursuant to the



name adopted by the petitioner.

3. The learned counsel for the petitioner relies upon the annexure – 8 in support of his arguments.

4. Mr. Farman Ali, the learned Standing Counsel for the respondent, seeks time to take instructions and file an appropriate affidavit.

5. Let the same be done before the next date of hearing.

6. The respondent is directed not to give effect to the impugned order till the next date of hearing.

1. That from the database of the Ministry of Corporate Affairs it has been observed that above name two companies are incorporated with identical name at different point of time. The status of both the companies are **"ACTIVE"**.
2. That the company no. 1 SPL INDUSTRIES LIMITED having CIN U17120MH1983PLC031599 was incorporated on 12/19/1983.
3. That company no. 2 with identical name SPL INDUSTRIES LIMITED having CIN L74899DL1991PLC062744 was incorporated on 12/6/1991. The company No. 2 is registered with Registrar of Companies, Delhi, which falls within the jurisdiction of this Directorate.



4. The Company no.1 & 2 has been provided with opportunity to make submission, if any, and Company No. 1 and Company No. 2 has submitted document/submission as under -

- i. None for Company - 1. As per postal remark on the undelivered envelope that "No such person in this address".
- ii. None for Company No.2 . However, a letter dated and 16.09.2024 24.09.2024 has been received from Company No. 2, inter-alia, intimating that the company no. 2 is originally incorporated on 012.06.1991 with name and style "Shivalik Prints Private Limited". Further, the company changed its name as SPL Industries Limited on 23.09.1994.

5. The Presenting Officer Shri Sanjay Kumar Gupta, Joint Director confirmed the aforesaid and recommends as under -

- i. The company no 2 was incorporated subsequent to the incorporation of the company number 1 and requires to change its name pursuant to requirement of sub-section 1(a) of Section 16 of the Companies Act, 2013.
- ii. The CRC may consider the new name with a single prefix/suffix in existing name of the company number -2 as the said company is doing its business with the same name since considerable time.

Now therefore, in exercise of the powers conferred by sub-section (1) (a) of Section 16 of the Companies Act, 2013 read with Notification No. S.O. 4090 (E) dated 19.12.2016, Ministry of Corporate Affairs, Government of India, this forum is of the view that the subsequent company is identical and deserve to change its name:



- i. The company **SPL INDUSTRIES LIMITED** having **L74899DL1991PLC062744** shall change its name within a period of three months from the date of this

order and by following the due process as required under the provisions of Chapter II of the Companies Act, 2013 and Rules made thereunder.

- ii. The Registrar of Companies, Delhi to take necessary action if, the Respondent company does not change its name within 3 months from the date of this order and issue change of name certificate on expiry of the period if the company number-2 is not changing its name within the aforesaid period.
- iii. A copy of this order be filed with the Registrar of Companies within the statutory timeline defined under the Act. CRC Shall consider the new name with a single prefix/suffix in existing name of the company number - 2 as permissible in law.
